**VENDOR/EXHIBITOR SPACE** HDE Agency reserves the right to limit food/merchandise/informational/nonprofit categories for each event. HDE Agency reserves the right to relocate booths at any time for the benefit of the event.

**PAYMENT FOR BOOTH SPACE** Payment IN FULL is due by January 27, 2012. Failure to pay the appropriate fee by the due date may result in loss of booth space.

**USE OF BOOTH SPACE** No vendor shall sub lease or share the assigned space. All demonstrations, sales, and/or promotional activities shall be confined to the assigned booth space only.

**CANCELLATION OF BOOTH SPACE** Fees are NOT refundable under any circumstances.

**INSURANCE** All participants must provide a Certificate of Insurance with liability limits of 1 million naming HDE Agency as additionally insured. Proof of insurance must be provided to HDE 2 weeks prior to event.

**ILLEGAL OR VIOLENT ACTIVITIES** Immediate closure of booth, expulsion from the event and possible legal action. There will be NO REFUNDS given. ALL vendors/sponsors will not participate in any illegal activity to include but not limited to public nudity, sale or use of drugs and or narcotics.

**IMPORTANT BOOTH SPACE INFORMATION:** To maintain booth décor and consistency, your booth space is limited to either the 10x10 or 10x20 space allotted. Expanding your booth or changing your location is strictly prohibited. Please remember to bring all signage, equipment and necessary items needed for your booth and event success.
